HISTORIC LOEWENBERG-ROBERTS MANSION • 1923 WEST FIRST AVENUE

A STUNNING MANSION WITH A **REGAL PRESENCE** ~ Commanding a regal presence from spreading, manicured grounds on a high knoll, the Loewenberg-Roberts Mansion is one of the finest Queen Anne style homes in Spokane and Eastern Washington.

It rises two-and-one-half stories with a third-floor finished attic, and supports a large three-story circular tower with a bellcast domed roof.

FINE ROMANESQUE STYLE

~ With strong influence from the Romanesque style, the house is prominently distinguished at the first floor with cut-granite cladding outlined in red brick trim, and applauds a reverse design at the second floor with brick cladding and cut-granite trim.

- THE DETAILS ~ Significantly characteristic of the Victorian period's Queen Anne style, the mansion is articulated with an array of decorative embellishments. including a massive segmental arched window of jointed cut-granite voussoirs, beveled bays, stainedglass windows, gable peaks with decorative shingles and ornamental plaster tracery, a second-story balcony with a wrap-around gallery, and an attached porte cochere (carport).
- CARRIAGE HOUSE & "SECRET" GARDEN ~ A large carriage house behind the home mimics the style and materials of the

mansion, and a walled secret garden on the property provides a venue for special tea parties.

WILLIAM J. CARPENTER ~

Erected in 1889, the mansion was designed by British architect, William J. Carpenter, who designed the Miller Block (now Hotel Lusso), the historic Coeur d'Alene Hotel (offices and Boo Radley's), and a number of fine residences.

THE LOEWENBERGS ~ The mansion was built for Bernhard & Harriett Loewenberg, owners and proprietors of a large dry goods store called the Loewenberg Mercantile, located in the Coeur d'Alene Hotel.



Unfortunately, a few years after construction of their home was completed, the Loewenbergs experienced a financial reversal during the economic "Panic of 1893."

- THE "TRADE" ~ With a provocative idea, the Loewenberg family "traded" their mansion a few years later for a smaller cottage on 2027 West First Avenue, owned by their friend and neighbor, Edwin J. Roberts and his wife, Mary Roberts. Roberts was a successful civil engineer for the Great Northern Railroad, served a president for the Union Iron Works in Spokane, and with his family lived in the Loewenberg-Roberts Mansion for over 60 years.
- REMARKABLE CONDITION ~ Today the Mansion survives in excellent condition and is well-preserved under the careful stewardship of owner Mary Moltke, who has spent over 30 years carefully restoring and furnishing the property.
- CELEBRATED HISTORICAL LANDMARK ~ The mansion is currently a celebrated historic landmark, the property is listed on the Spokane, Washington State and National Registers of Historic Places. It is open to the public as the Roberts Mansion Inn & Events.



A BUSY MONTH ~ October was a busy month for the Heritage Grant Committee! We closed out four previously granted projects and are sending a fifth to the SPA Board for approval in November.

COMPLETED PROJECTS INCLUDE:

\$5,000 • Jonas Babcock Chapter • DAR

For the restoration of the 1930 American Legion Cenotaph in Riverside Memorial Park. The Cenotaph is a memorial honoring WWI veterans who are interred elsewhere.

\$5,000 • Northwest Museum of Arts and Culture

For reproduction and installation of wallpaper for Chambers 10 and 12 in the Campbell House, which is celebrating its 125th year.

\$5,000 • The Rockwood Neighborhood Council

For grading and restoration of one of three historic brick trolley stops.

\$5,000 • Saint John the Evangelist Cathedral

For repairs on the gutter and downspout to mitigate water intrusion and resulting damage to the structure.

The Heritage Grant Committee is also recommending approval of \$5,000 toward replacement of failing double-hung, single-pane windows in the 1926 administrative addition to Westminster Congregational Church.

SPA's Board will consider approval of this at their November meeting.

HISTORIC PRESERVATION OFFICE UPDATE

- TWO LARGE GRANT SURVEYS ~ The Spokane Historic Preservation Office completed two large grant projects in September of 2023 ~ the East Central Historic and Cultural Survey and a Spokane County Markers, Monuments and Objects Survey. Both projects are available on our website (historicspokane.org) under the "Projects" tab if you are interested in seeing the full details.
- THE EAST CENTRAL STUDY ~ This study documented over 800 properties between Liberty Park and Thor, and 4th Avenue to the bluff at the south. Our goal was to document this neighborhood by discussing the different eras of development from the initial early days of settlement through the period when the neighborhood was divided in two by the construction of Interstate 90.
- THE SPOKANE COUNTY MONUMENT, MARKER & OBJECT CONTEXT AND SURVEY ~ This survey is a written and pictorial context of historic monuments, markers, and objects in Spokane County. These objects, constructed as early as 1893, represent and interpret some of the most significant and controversial historic sites in the county. They include battlefield sites, the sites of war crimes against local tribes, a controversial statue to a U.S. Naval Officer, historic trails, tribal villages, and location markers for significant buildings or remnants.
- SPECIAL FUNDING ~ Historic Preservation is excited to have received funding from the Washington State Department of Archaeology and Historic Preservation to prepare two nominations to the Spokane Register for underrepresented resources associated with Spokane's Black community.
- ADDITIONS FROM THE LANDMARKS COMMISSION ~

The Spokane Historic Landmarks Commission has listed a few additional buildings on the Spokane Register of Historic Places this year. This list was previously updated in May 2023. Those listings include The Parkade at 511 West Main Avenue and the Alex and Fanny Ritter House at 702 West 21st Avenue. We are currently reviewing the Arthur and Florence Davis House at 306 West Graves Road (November) in Spokane County. The end of the year is busy with Special Valuation application reviews. This year will end with 13 applications totaling \$12.5M invested in historic properties in Spokane.

ADVOCACY UPDATE

- A GOOD THING ~ Things continue to be relatively quiet on the Advocacy front ~ a good thing! Although there are no immediately pressing advocacy issues on our radar at the moment, we are keeping our eyes on a few items that may come to the forefront soon ~ plus one old friend, The Chancery Building. No news continues to be good news with respect to it ~ at least for now. The development plans that were floated last year by the property owners have yet to move forward. It is still abandoned, however, and is likely to continue to decay without action from ownership, which doesn't appear forthcoming. SPA continues to try to locate a preservation-minded buyer for this important building.
- STATE POLICY UPDATES ~ While much attention over the past few years has focused on housing policy, those codes have been adopted at the state and local levels with numerous preservation-friendly elements.
- **NEXT FRONTIER** ~ The next major frontier from a policy perspective will be energy codes, which have been passed by the Legislature and are in the rule-making process now.

While SPA wholeheartedly supports efforts to reduce the energy use of buildings, we do have concerns that the retroactive way in which these codes are written could lead to large-scale demolition of older buildings as they are often prohibitively expensive to bring into conformance with the new code. Look for more information to come on this important issue soon.

• INSURANCE INDUSTRY ~ As building costs continue to skyrocket, we are hearing that some insurers are beginning to balk at covering historic buildings due to untenably high replacement costs. This too is a developing issue and will receive more coverage from SPA in due course.
